IN THE OFFICE OF THE JUDGE OF PROBATE, MOBILE COUNTY, ALABAMA

Members of the Blue Springs Baptist Church being desirous of becoming incorporated for the purposes of holding title to properties and matters purely temporal and material; and

The Board of Trustees of said Church having fixed a date for a meeting of the members of said Blue Springs Baptist Church for the purpose of having said members pass on the question of whether or not they should become incorporated, and if so to elect a Board of Trustees for said Church; and

Due and proper and legal notice having been given to the members of said Church by the Pastor of said Church as directed by the Board of Trustees, and said members of said Church, pursuant to the call of said meeting of the Trustees and notice given by the Pastor of the Church of the time and place and purpose of said meeting, having met at the Church on the 7th day of August, 1960, and there being a majority of said members of said Church present at such meeting, and said members in meeting assembled having duly adopted on the 7th day of August, 1960, a resolution signifying their desire and intention to become incorporated and selecting the name of said Church, and having elected a Board of Trustees for said Church, and fixed their respective terms; and






1. The corporate name of said Church is the Blue Springs Baptist Church.
2. The names of the Trustees and the length of time for which they were elected are:




